1. **Purchaser** shall not have the right to broadcast, televise, photograph or otherwise reproduce the performances or any part thereof. **Purchaser** shall have their representative announce the above agreement at the performance .
2. **The Artists** shall have sole exclusive rights, but not the obligation, to sell merchandise and retain 100% of the receipts unless otherwise agreed to in writing by the artist. The sole exception is to any financial arrangements made with venue for the handling and / or sale of this merchandise. **The purchaser** is enjoined from selling any merchandise bearing the likeness of the Artist or any member individually.
3. **Purchaser** to provide professional stage lighting for each performance. **Purchaser** is to provide a high quality professional sound system large enough to accommodate the room without distortion (16- 24) channels minimum. A minimum of 3 quality monitors and 5 high quality microphones with at least 3 cords long enough to reach the entire stage and front row audience. A large enough sound board to accommodate the miking of other stage equipment.
4. (A separate monitor mix is preferred)
5. When purchaser provides musicians, they shall consist of bass guitar, guitar, keyboard and drummer. When purchaser provides equipment, please provide the following; 1st class 5pc. drum set, bass and guitar amps, 1st class keyboard with stand and amp. **If horns** are hired by the purchaser for any of the other acts on the same bill, they shall be made available, **at no charge to The Crystals, in advance of the date**, so that musical charts can be sent to them to familiarize them with The Crystals show. All musicians **MUST** be able to read music (notes and chords) and follow directions of conductor if provided .They should be available for rehearsal for 1-2 hours (4-5 hours prior to performance) and dressed in dark colored suits during the show.
6. **Purchaser shall provide the artist with a clean locked dressing room, equipped with towels, sink with running hot and cold water, toilet, mirrors adequate for applying makeup and a rack for the hanging of their costumes. Adequate heat shall be provided in the winter and air conditioning in summer.**

7. Hospitality shall be bottled water, hot tea, coffee, deli tray, fruits, cheeses, and soft drinks.
8. On all engagements when air transportation is the obligation of the purchaser, artist shall at it's option choose between cash equivalent of round trip tickets based upon lowest available coach air on the days of arrival and departure OR airline tickets from it's previous engagements to destination under this contract.
9. When required and agreed upon, the following will be provided for the Artist 4 single rooms, prepaid, at a 1st class hotel close to the venue. If a band is provided by the Artist, the Purchaser shall also provide _____ rooms for the band. (with 2 night option).
10. **Purchaser** shall provide ground transportation to and from airport, hotel and venue
11. **The Artist** shall be paid in full for any date for which they show up regardless of ticket sales, weather conditions, riots, tax liens or any act of God.
12. All deposits are due upon signing of contracts unless other arrangements are written into contract and agreed upon. If deposit is not received by due date on contract. Artist has the right to cancel date. Deposits are non- refundable
13. All artists have the right to cancel any date up to 45 days prior to engagement if they are booked on a national television show, a casino date, or any major convention.
14. **All balances to be made prior to performance in cash only to artist.**
15. **This rider shall be abided to and signed by purchaser. Failure to comply with this rider shall cause cancellation of engagement.**
