**DRESSING ROOM**

A) A CLEAN WELL LIT AIR CONDITIONED "**DRESSING ROOM**" SUFFICIENT FOR "**ARTIST COMFORT**".

B) CLEAN CLOTH (TERRY) TOWELS FOR ARTIST AND THEIR MUSICIANS, AT LEAST (amt depends on how many musicians, Cups & dressors) EX:FOURTEEN (14) PLEASE.

**CATERING**

- A) COLD BEVERAGES TO INCLUDE BOTTLED WATER, DIET CAFFEINE FREE & REGULAR COCA COLA & 7 UP, (PLEASE NO PEPSI OR SPRITE). FRUIT JUICES, SLICED LEMONS & ASSORTED TEAS WITH “HOT” WATER PLEASE, THANK YOU.
- B) FRESH DELI/FRUIT TRAY (# to be determined) FOR SIXTEEN (16) PEOPLE. BEER NOT NECESSARY. (DON'T FORGET THE “HOT” WATER FOR THE TEA, THANKS).

**PRESENTATION**

ARTIST MAINTAINS MUTUAL CONTROL OVER THE PRESENTATION AND THE PERFORMANCE HEREUNDER. ARTIST OBLIGATIONS THERETO ARE SUBJECT TO DETENTION BY ACT OF GOD, ACTS OR ORDERS OF PUBLIC AUTHORITIES, TRANSPORTATION, ILLNESS, ACCIDENT, STRIKES, RIOTS, ACT OF WAR, NATIONAL DIASTERS SUCH AS HURRICANE, FLOOD OR TORNADOS, ACTS BY TERRORIST, OR ANY CAUSE BEYOND ARTIST CONTROL.

**MISCELLANEOUS**

PURCHASER SHALL MEET SPECIFIC VENUE INSURANCE REQUIREMENTS, AND SHALL NOT ASSIGN ANY PROVISIONS OF THIS AGREEMENT OR INCLUDE THE PERFORMANCE IN ANY SUBSCRIPTION. PURCHASER SHALL NOT KNOWINGLY ALLOW ANYONE THE RIGHT TO BROADCAST, TELEVISE, VIDEO (CAMERA AND/OR CELL PHONES) OR OTHERWISE REPRODUCE THE PERFORMANCE, HEREUNDER, OR ANY PART THEREOF WITHOUT THE EXPRESSED WRITTEN PERMISSION FROM THE ARTIST, **EXCEPT TV NEWS COVERAGE LIMITED TO TWO (2) SONGS.**
