PERSONAL / TECHNICAL RIDER

BILLING ATTRACTION: Carla DelVillaggio, Barbra Streisand Tribute Artist, as “*Simply Streisand...a Tribute to Barbra Streisand,*” accompanied by a live ___-piece band. There will be a 10-15 min. intermission.

SCENERY/PROPS: Ms DelVillaggio will bring the following scenic elements with her as part of her “show”. These items may include: small round table, tall stool, teapot with tea cup and saucer, several small hand props, promotional items to sell after the show, etc.

TECHNICAL REQUIREMENTS: Purchaser will provide all sound and lighting equipment (including follow-spot) appropriate for this venue, and equipment operators as follows:

Additionally (if Video elements are requested by client, they should provide):

- 1) Video screen, DVD player (or laptop with USB port for flashdrive), and projector
- 2) Ms DelVillaggio will provide sound and lighting cue sheets.

DRESSING ROOM REQUIREMENTS: Purchaser will provide clean, private and secure dressing area close to the stage for Ms DelVillaggio and her personnel, with plenty of light, chairs, table, long mirror, bottled water and light snacks. It is requested that there be restrooms close to the dressing area as well, other than those used by the audience – whenever possible.

ADDITIONAL TERMS/AGREEMENTS: It is understood that Carla DelVillaggio executes this agreement as an independent contractor and is responsible for her own taxes, contributions and all other obligations. Ms. DelVillaggio is solely responsible for payment to her subcontractors. They also are independent contractors and responsible for their own taxes. Carla DelVillaggio is not an employee of the Purchaser and expressly reserves the right to control the manner, means and details of the performance.

Carla DelVillaggio should be billed as a *Tribute Artist* in all media, advertising and promotional materials and under no circumstances are audience members to be led to believe that the real Barbra Streisand. Purchaser assumes all liability in connection with any lawsuits filed against Carla DelVillaggio as a result of Purchaser’s failure to comply with the aforesaid terms regarding advertising and promotion. Allowing Carla DelVillaggio to perform is construed as acceptance of the terms of this contract even in the absence of signatures of Purchaser and Carla DelVillaggio. It is understood that the Purchaser assumes liability for equipment damage or personal injury due to the action of the audience or any other action or event under Purchaser’s control. Purchaser shall indemnify, defend and hold Carla DelVillaggio harmless from and against all claims, costs and reasonable attorney’s fees sustained, incurred or required to be paid by Carla DelVillaggio that relate to or arise out of

the contract between Carla DelVillaggio and Purchaser. Carla DelVillaggio shall not be responsible for personal injury to audience member(s) prior, during, or after performance as a result of accidents, or Force Majeur. Carla DelVillaggio does carry Liability Insurance in the amount of \$2,000.000 and can provide copy upon request.

No performance of the engagement shall be recorded, reproduced or transmitted from the place of performance, in any manner or by any means whatsoever in the absence of a specific written agreement with Carla DelVillaggio and permitting such recording, reproduction or transmission.
